

**RESOLUTION**  
**scientific and practical conference with international participation**  
**to the 140th anniversary of the birth of O.M. Marzeeva**  
**“Current Issues of Public Health and Environmental Safety of Ukraine”**  
**(19 Marzieiev readings).**

**We, the participants of the nineteenth Marzieiev readings, gathered at the scientific and practical conference "Current Issues of Public Health and Environmental Safety of Ukraine" to scientifically strengthen the public health system and to determine strategic directions for the development of preventive science in the field of "environment and health.**

**According to the Declaration of the Seventh Ministerial Conference on Environment and Health, COP 27, the Resolution of the World Health Assembly, the European programs "Joining Efforts for Better Health" and One Health for Dissemination and Effective Use of Scientific Materials:**

1. We approve the focus of scientific research on the European basis of WHO activities in emergencies outlined in the "One Health" and "International Medical and Sanitary Regulations" programs;
2. We recommend focusing attention on the issues of the effects of war on the state of physical and mental health of the population, the development of security strategies for protection against military actions, climate change, and social pressure, which will determine the effective implementation of the Recovery Plan of Ukraine;
3. We note that the development of the public health system in modern conditions should be based on the implemented nationwide principle "Health care in all state policies", which requires strengthening the use of multisectoral management tools;
4. We propose to jointly develop a methodology for assessing the medical and environmental damage of the impact of the consequences of the war on the health of the population;
5. We recommend preparing measures to minimize the negative impact of military aggression on the health of the population;
6. We consider it necessary to use scientific research for the implementation of health promotion programs among children, adolescents, and students, displaced persons from temporarily occupied territories, pregnant women, and the elderly.
7. We support the need for scientific substantiation of requirements for the nature, composition, and volume of food for the civilian population and the military through the adjustment of rations, dietary nutrition, and the use of special means of increasing the adaptation capabilities of the population to the negative impact of environmental pollution and military operations.
8. We appeal to the professional, and political environment, and representatives of civil society to strengthen the explanatory work on the functions of the health care

system, as a continuous, multi-vector, and interdisciplinary process, in which all structural levels are involved: individual-group-community-society;

9. We call to intensify the implementation of innovative scientific developments in the practice of health care, which are aimed at the prevention of non-infectious and infectious eco-dependent diseases;

10. We emphasize the need to strengthen activities in the field of "One Health", to develop preventive measures against the spread of antibiotic-resistant microorganisms.

11. We are initiating the creation of a single civil platform for the unification of non-governmental organizations that take care of the development of the public health system.

12. We continue to promote the conditions for the further development of cooperation with international organizations and universities in the direction of "Environment and health", and "Public health" and training personnel for preventive medicine.

13. We consider it expedient to contact international organizations with a proposal regarding the need for an urgent review and amendment of the international standard "INTERNATIONAL STANDARD CLASSIFICATION OF EDUCATION /Fields of education and training 2013 (ISCED-F2013) Detailed field descriptions regarding the creation of a code for the specialty - "Public health".

14. We create favorable conditions for the further development of cooperation with international organizations and universities in the direction of "Environment and health", and "Public health" regarding the training of personnel for preventive medicine, improvement of competencies, formation of leaders.
